 - 1.1.2. The chair Pastor Ken Gehrels welcomes all. He encourages delegates when they speak to introduce themselves, where they are from and please do not use acronyms, etc.
- 1.2. Roll call...classis declared constituted.

- 2.1.3. Working on learning about CEC Webpage.
- 2.1.4. Correspondence from Rev. Bert Vanderbeek and Rev. Simon Speelman referred to CIC.
- 2.1.5. Contacted Synodical Deputies re Bert Vanderbeek's request.
- 2.1.6. Working on CEC bylaws with Rev. Jack Van de Hoef. Contacted Ross McBride [Hamilton Law firm used by denomination] to review By-laws. Work is progressing.
- 2.1.7. Received various Classical and Denominational reports for CEC fall agenda...reports in agenda.
- 2.1.8. Received and forwarded materials to office administrators to distribute as per local policy.
- 2.1.9. Received Ecclesiastical Credentials for Rev. James Kralt, new pastor in Montreal CRC.
- 2.1.10. Received Ecclesiastical Credentials for Rev. Dan Hoogland, new pastor in Fredericton CRC.
- 2.1.11. Received Ecclesiastical Credentials for Rev. David Kromminga, called by All Nations CRC, Halifax to serve with Resonate Global Mission in Berlin, Germany.

2.1.12. Motion that CEC adopt work of Stated Clerk Adopted

- 2.2. Classis Interim Committee Piet Heerema [vice-chair]; Att. 2
 - 2.2.1. 1. The CIC has met twice since the March meeting of Classis to address matters of Classis concern and to prepare for this meeting of Classis. Some of the requests to address Classis are included in this agenda, while others will be part of the March 2019 meeting.
 - 2.2.2. We thank Richard Smit for serving as Stated Clerk over the past years. We appreciated his stepping up to the plate when previous clerk was no longer able to serve.
 - 2.2.3. A review and edit of the Rules of Procedure and By-laws has been done by Bernie Bakker and Jack Van de Hoef. After receiving legal advice on preliminary changes, further editing is necessary. Unfortunately, a full report is not yet possible (as promised in March 2018.) We anticipate that this will be presented to the March 2019 Classis meeting.
 - 2.2.4. CIC is also looking into current storage of printed and electronic records of CEC and trying to locate the seal of Classis. The Stated Clerk has the information needed to update the Classis web page. NOTE: The records, etc. located and reside with Stated Clerk

- 2.2.5. In response to a letter of concern from the elders at All Nations CRC, Halifax, identifying misunderstanding and hurt experienced by a delegate at the last Classis meeting, Bernie Bakker and Michelle De Pooter [via video] met with the elders. There was a healthy spirit of listening and understanding, leading to reconciliation. All Nations elders considered their concerns to be adequately addressed.
 - 2.2.5.1. All Nations CRC Halifax Council response to 2.2.5 above is noted below:
 - we believe that the word "misunderstanding" is a mistaken term (as was earlier pointed out to and agreed upon by CIC in earlier communications between CIC and our Elders), and unfairly puts the blame onto the hurt All Nations delegate;
 - we believe that the absence of the word "racism" is a mistake, and lament that such an injustice was not named;
 - we believe that stating there was "reconciliation" is a mistake the point of CIC's and our Elders' meeting was for listening, not for reconciliation; no reconciliation – at least not personally – has taken place; and
 - we regret that CIC, in reporting on the meeting between CIC and our Elders, did not engage our Council or Elders in drafting the report – that is, that the narrative of the events was the responsibility of only one party, the result being that we again have to argue for the veracity of our delegate's hurt and the truth of their claims.

Again, we thank CIC for responding to our initial letter of concern and the care they did give to our elders.

- 2.2.6. The CIC discussed the concerns further and will be suggesting some follow-up steps for Classis. These include:
 - 2.2.6.1. Help classis to grow in having a welcoming culture as we continue to develop sensitivity to various backgrounds.
 - 2.2.6.2. We are in communication with Race Relations Canada, and are working on a workshop for the March/October 2019 meeting of classis.
 - 2.2.6.3. The Classis Hosting and Delegate information forms have been updated to reflect greater clarity regarding process and expectations.
- 2.2.7. Authorized the following people to have signing authority at bank on behalf of CEC Eva Reitsma, Joe Groeneveld, Aaron Thompson, and Jean Lauziere.
- 2.2.8. Responded to Kentville CRC's request to permit Justin Halbersma to lead in Lord's Supper service. Permission was granted during months when there are no classical appointments.
- 2.2.9. Responded to questions regarding the status of Bert Vanderbeek's credentials and support the recommendations being presented to Classis. Synodical Deputies will be notified for their support by email. Also processed the request of Rev. Siemen Speelman for early retirement as October 21, 2019 under CO Art 18. Both matters referred to Ministerial Credentials Committee for recommendations to CEC.

Motion that Classis close The Vine Campus Ministry (Dalhousie) effective immediately. Adopted

Grounds:

 - 4.3.1. Rev. Bert Vanderbeek request eligibility for call to be extended one year. Background:

Rev. Bert Vanderbeek has requested to be granted the status of being eligible for a call for a one-year period starting in October 2018. At the end of 2017 Bert stepped down from his role of Stated Pulpit Supply at Kentville CRC. Normally, an ordained and called minister would be granted a two year period of eligibility for a call. However, in this case, though an ordained Minister of the Word, Bert was never officially called to Kentville. The support letter from the chair of CIC (Jack van der Hoef) and Bert's Regional Pastor (Dave Vroege) recommends that we, with the concurrence of the Synodical Deputies, declare Rev. Bert Vanderbeek eligible for a call for a period of one year. This would give Bert the normal total of two years of eligibility for a call, and therefore allow him the time normally allotted to receive a call and to discern God's direction in his life.

Motion: that Classis approve Rev. Vanderbeek's request to be granted the status of being eligible for a call for a one-year period starting in October of 2018.

The committee recommends that Classis not accede to the Canadian Ministries' request for a second year of funding for the "Bridge" app. Adopted Grounds:

While it is a good app, and we heartily recommend that individual churches investigate and consider seriously using this app for the advantages it provides, it would be financially irresponsible for us a Classis to continue to pay the "group" rate. Specifically:

- Our Classis fits in the "medium" classis category which means that we pay \$6000.00/yr to use the app.
- Paying individually for each church would come out to \$330.00/yr*19 churches (\$6270.00/yr). Going with the group rate of \$6000.00/yr would then constitute a savings. However, if even one church does not make use of the app, we would be paying more if we pay the group rate (\$6000.00 vs. \$5940.00).
- At our current usage of 7 churches, the app effectively costs approximately \$857.00/yr
