1. Constitution of Classis

- 1.1. Welcome and opening worship led by Rick Nanninga, pastor of Barrhaven Fellowship CRC one of host churches. He reads from Ephesians 1 emphasizing the need to remember the "big picture" of God's Kingdom/Mission in our work.
- 1.2. Chair of Classis, Pastor Craig Hoekema welcomes all and declares CEC constituted.
- 1.3. Roll call and constituting classis
 - 1.3.1. Rev. Dave Vroege is absent as his wife Carrie is ill with heart issues. We will keep them in our prayers.
 - 1.3.2. We praise the Lord that Rev. Paul Vanderkooy is able to attend Classis as he has not been present for past three years due to a concussion.
 - 1.3.3. Guests: Richard Smit World Renew; Michelle DePooter Seafarers Centre, Montreal; Michele Glyselinck – Disability Concerns Advocate; Rebecca Walker – Refugee Coordinator; Anita Hoogeveen – Diaconal Ministry Developer West
 - 1.3.4. Rev. Aaron Thompson arrives in early afternoon.

2. Reports – Standing Committees of Classis

2.1. Stated Clerk: Bernie Bakker - Att. 1

2.1.1. Motion to approve work of stated clerk

- 2.2. Classis Interim Committee: Jack Van de Hoef Att. 2
 - 2.2.1. Brian Vandenberg of Dixons Corners CRC sat in on CIC meeting to observe and is now a member of CIC.
 - 2.2.2. The CIC has been working with Bernadette Arthur, Race Relations Coordinator in Canada, to prepare discussion material for Councils and Classis on the topic of unity, diversity and racism. The March 2019 Classis meeting will include a time for interaction by delegates on their Council discussions. At the October 2019 Classis meeting, Bernadette is scheduled to lead us in a workshop on "Cultural Intelligence".
 - 2.2.3. On a question regarding Classical appointments, clarification was given that a Pastor will be required to serve for no more than three appointments per year.
 - 2.2.4. Regarding delegates to Classis meetings, CIC would remind the churches that Church Order Article 40 states three delegates will be sent from each congregation – pastor, elder, and deacon. An elder may serve in place of a pastor, but not in place of a deacon and a deacon may not serve in place of an elder. The purpose of having deacons at Classis is to include the input from the office of deacon, not to provide 3 votes from each church.
 - 2.2.5. CIC reminds all ministries of the decision of Classis in October 2018 that a 3-5 year ministry plan is to accompany all annual budget requests. If no plan is submitted, the budget line will be frozen. The FAC is requested to attach all Ministry Plans to the annual proposed budget to support that line item.
 - 2.2.6. Upon recommendation from the FAC, the CIC recommends to CEC that churches hosting Classis meetings will receive a fixed fee of \$1800 for remuneration to go into effect March 2019. Adopted
 - 2.2.7. Upon recommendation from the FAC, the CIC recommends to CEC that effective April 1, 2019 remuneration for preaching be set at \$150 (currently \$100) and starting January 1, 2020 remuneration will be \$200. Adopted FAC is asked to review this every 3 years.
 - 2.2.8. The reimbursement for Classical mileage will remain at 45 cents per km.
 - 2.2.9. CIC would like to remind Classis that our Rules for Procedure state that Classis will meet in the Maritimes once every four years. We met in Charlottetown in October 2016,

so the next meeting would be in October 2020. Our Rules also state that "Funds for travel shall be set aside on a yearly basis."

- 2.2.10. As church councils have previously received the revised bylaws for CEC, the CIC recommends that Classis Eastern Canada approve the Bylaws Att. 2a. Adopted
- 2.2.11. CIC approved 10 delegates from CEC to attend the National Gathering in May 2019.
- 2.2.12. The revised **Rules of Procedure** will be sent to church councils after the March 2019 meeting. Any suggested changes must be received by the Clerk by June 7, 2019. A final revision will be sent to church councils for approval at the October 2019 Classis meeting.

 - 5.1.1. Request from Kentville CRC, NS that office bearer Justin Halbersma be granted permission to celebrate the sacraments.
 - 5.1.1.1. The Correspondence Committee recommends that Classis rule that "Mr. Justin Halbersma be authorized to administer the sacrament of Lord's Supper to our congregation on a regular basis", as per Kentville CRC's request.

3. We agree that the present circumstances constitute "need" and are exceptional circumstances.

- 5.2. Credentials & Instructions: Fredericton and Milford
 - 5.2.1. After reviewing the credentials, we find that they are in good order.
 - 5.2.2. Nominations to Synod:
 - 5.2.2.1. Calvin Christian Reformed Church nominates Ron Hosmar, their pastor of youth and congregational life, as an elder delegate to Synod 2019.
 - 5.2.3. Questions from the congregations:
 - 5.2.3.1. Athens & Pembroke CRC How do we grow our church?
 - 5.2.3.1.1. Response: Look for resources and ask your question on the CRC's network. Speak with Rev. Rick Nanninga, who serves with Classis Resonate Global Mission West.
 - 5.2.3.2. Williamsburg CRC How do other congregations deal with the rental of their sanctuary for events other than worship services (ie: weddings, funerals, concerts)

- 5.2.3.2.1. Response: If there are congregations that have worked through this same question of renting out their space, please speak to the delegates at Williamsburg CRC.
- 5.2.3.3. How to effectively minister to members of the congregation and communities who need practical help like meals, rides to church, or appointments.
 - 5.2.3.3.1. Response: If there are congregations who have responded to this need, please speak to the delegates at Williamsburg CRC. Speak to the delegates at Fredericton CRC: there is a ministry in Fredericton that is operated by several congregations called neighbourhood link, which offers this service to the community at large.

- 6.1. Council of Delegates Bernie Bakker
 - 6.1.1. He explained the work of COD as a bi-national body overseeing work of the Christian Reformed Church between Synod meetings.
 - 6.1.2. Congregations encouraged familiarizing themselves with Canadian and US webpage of crcna.org to find ministry resources. In addition use the One Call [800-272-5125] asking where resources can be found.
 - 6.1.3. Let's consider attending the "Inspire Conference" in Windsor on August 1-2, 2019
- 6.2. World Renew Richard Smit
 - 6.2.1. Richard encourages all congregations to consider sponsoring refugees. We are encouraged to speak to our Members of Parliament to permit private sponsorship which at this time is closed.
 - 6.2.2. Rebecca Walker Refugee Coordinator
 - 6.2.2.1. Rebecca shares history of Refugees coming into Canada and encourages congregations and private sponsors to work through the Burlington office.
- 7. Calvary Overture re Climate Change: Truro and Athens
 - 7.1. The overture committee recommends that Classis Eastern Canada not accede to the overture [report on file].
 - 7.2. Ottawa Calvary CRC moves the overture for presentation and discussion.
 - 7.2.1. Following discussion and deliberation the recommendations of the overture are defeated [Calvary Overture on file].

8. Faith Formation Workshop led by Lesli van Milligen: "Creating a Leadership Culture: How can congregations identify, develop and support new and existing leadership so that leading itself is life-giving and faith formative?"

Saturday, March 2, 2019 session

- Chair Craig Hoekema opens with devotions
 9.1. Absent Pembroke delegates; Deacon Heine Veerman due to illness.
- 10. Ministry to Seafarers Montreal: Seafarers Chaplain Michele DePooter Att. 6
 - 10.1. Michele gives update of work at the Seafarers Centre in Montreal. She is so thankful for the other chaplains and volunteers who give of their time.

- 11. Canadian Ministries Director Darren Roodra
 - 11.1. Darren updates classis on his work in Canada. Congregations are encouraged to try to Bridge APP despite earlier issues.
 - 11.2. We are looking forward to the "Gathering Conference" in Edmonton on Victoria Day weekend.
 - 11.3. He mentions Canadian Classes that went through a renewal process and are experiencing growth.
- 12. Ottawa Campus Ministry Chaplain Syd Ypma
 - 12.1. Syd shared his message via YouTube video from his campus office. He shared some stories of student who come in with questions over a cup of coffee. He has the opportunity to share grace and pray with the students concerning their challenges and concerns. Syd shares that he will take a sabbatical from April to June this year focusing on the CRC testimony "Our World Belongs to God" and how it interacts with world religious conversations he has had with students at the University over the years.
- 13. Redeemer University College Syd Ypma
 - 13.1. Redeemer installed the new president this weekend. Mention is made that tuition is been lowered by 40% for the next five years due to a significant donation.
- 14. Financial Administration Committee (FAC) Eva Reitsma, treasurer
 - 14.1. Classis Eastern Canada Financial Statement for 2018 is presented for review.
 - 14.1.1. Motion to approve the Financial Statement as presented. Adopted
 - 14.2. The FAC reads their recommendations regarding surplus funds.
 - 14.3. Overture Committee re Ottawa Calvary CRC overture regarding VINE Ministry funds [Dixons and Cornwall] recommend that Classis not accede to Calvary CRC's overture re: VINE Funds.
 - Grounds:

1. The FAC Report submitted to Classis provides an alternative plan for the use of the VINE Funds that seeks to support the OCRCC (Ottawa Christian Reformed Campus Chaplaincy) – including a one-time contribution of \$15,000 and openness to further considerations on an annual basis – and other classis ministry with grounds for each financial decision. (See Report: "FAC Recommendations for allocation of surplus realized in 2018 budget")

2. The FAC recommendations take into account the many different financial obligations of Classis – and not solely the OCRCC – while seeking to be wise stewards of these funds.

3. The FAC recommendations do not preclude the OCRCC from submitting a request for increased funding from Classis through the normal budgetary process.

- 14.4. Calvary church council withdraws their overture so Classis can move to FAC recommendations below.
- 14.5. FAC moves recommendations 1 6:
 1. Travel Costs for October 2020 classis meeting: The FAC recommends that CEC allocates \$6,206 for travel costs for the 2020 budget as directed by the CIC.

Grounds: The CIC informed the FAC that the October 2020 meeting will take place in the Eastern part of CEC and the FAC wanted to allocate those funds now to reduce budget fluctuations. These funds would be placed as a separate line item in the general fund section until utilized.

2. Ottawa Christian Reformed Church Chaplaincy (OCRCC):

The FAC considered the allocation of funds remaining in our accounts as a result of the ending of the Vine Campus Ministry and not hiring a Classis Ministry Outreach staff person in 2018. We recognized the significant contributions made to the OCRCC ministry from the Ottawa area churches and the pressure a campus ministry experiences to raise funds from other sources or ministry alumni. Our discussion brought us to two recommendations:

We recommend that Classis make a one-year contribution in the amount of \$15,000 to ease the pressure for fund-raising in OCRCC's 2019 budget.

Grounds: Currently OCRCC is seeking \$32,159 in its "Other Donation" line item and FAC would like to help them offset that with a one-time allocation recognizing that, as the ministry matures, it is reasonable to expect increased support ministry from alumni and our support in 2019 is not intended to replace those efforts. Depending on the end-of-year status of the Classis' budget in 2019, the Committee would be open to future considerations on an annual basis.

3. Classis Ministry Leadership Team (CMLT)

The FAC recommends that CEC allocates \$20,000 to the operation fund of CMLT. Grounds: Currently three seminary students are being supported and funds will be needed to sustain this fund over their time in Seminary. This \$20,000 will help reduce possible fluctuations in budget requests in the future, especially if any more students are added.

3. Fund to help struggling churches

The FAC recommends that CEC allocates \$15,000 to create a new fund to assist churches in our classis who are struggling.

Grounds: The FAC is aware that this request has been talked about informally and after discussions as an FAC we feel it warranted, and a stewardly use of CEC surplus funds. We would suggest that any requests for assistance be made to the CIC and a process for approval for dispersal be discussed in the CIC.

NOTE: A discussion also mentioned that no funds would be dispersed until allocation processes were in place, earliest this could be done would be our NEXT classis meeting.

4. Campus Ministry out East (Dalhousie)

The FAC recommends that CEC allocates \$10,000 to a holding fund for possible Campus Ministry in Dalhousie University.

Grounds: Though the Dalhousie Campus ministry has ceased to exist, there is talk that new possibilities could emerge in a couple of years. New ideas like hiring a part time intern could be possible, so the FAC wanted to allow for a fund to begin thinking anew about Campus Ministry at Dalhousie. Elder delegate Dale Poel can speak to this. Funds to help offset 2019 budget of \$10,000 was already agreed to at the October 2018 classis meeting.
