Friday, March 4, 2022 @ 6 pm EST

1. Constitution of Classis and Opening Devotions

- 1.1. ZOOM link opens at 6 pm; at 6:15 pm delegates move into breakout rooms for time of getting acquainted.
- 1.2. Host church Fellowship CRC, Ottawa Barrhaven Pastor Rick Nanninga, leads in opening devotions. Portions of Acts 15 & 16 form foundation of devotions. Rick shares some thoughts by Susan Beaumont, [How to Lead - When You Do Not Know Where You are Going](#). The concept of "liminality" happened in the Bible and is present today. We sometimes do not know where we are going as pastors, elders, deacons...we feel stuck; what direction should we go. Similar to first synod in Acts. Paul and Barnabas go out to various churches and report the decision. Yet in the end there is division when they cannot agree about Mark coming with them; read vv 6 – 15; Liminality led them to new places..."to the riverside" to proclaim the gospel; a new church was established by women ...God works in surprising ways to grow His church. In a liminal setting we need to keep looking to the Holy Spirit to lead us.
- 1.3. All congregations are represented by their delegates. Pastor Rick notes:
 - 1.3.1. Immanuel CRC, Cornwall is not able to send delegates.
 - 1.3.2. Pembroke has two deacon delegates, one seated as an elder.

- 1.3.3. Pastor Don Draayer, interim pastor in Charlottetown, is seated as a delegate.
 - 1.3.4. Pastor Rick declares Classis Eastern Canada is constituted and introduces the executive.
2. Rev. Joe Groeneveld serves as chair and Rev. Jack Van de Hoef is vice chair for the meeting.
 - 2.1. Pastor Joe thanks Rick for his devotion.
 - 2.2. The chair explains some details re a ZOOM meeting; thanks to Ron Hosmar and Michelle DePooter for serving as technicians for the meeting; ministry representatives and guests are welcomed. A total of 64 delegates, alternate, and guests are registered for the ZOOM meeting.
 - 2.3. Our condolences to Gayla Postma, a former Stated Clerk of CEC and former news editor for The Banner, in the passing of her husband Gary. May Gayla and her family experience the comfort and peace of our Saviour and Lord.
 - 2.4. Condolences also to Rene Wall and family as her brother-in-law was killed in a car accident in Nova Scotia this past week. May the John Calvin CRC congregation know the peace of Christ in this season of great pain.
 - 2.5. Condolences also expressed in the sudden death of Pastor Brian Barr who served several CRC Eastern Ontario congregations as interim pastor. He was a servant of compassion who officiated at numerous wedding and funerals for CRC families. May his family and friends experience the comfort of Jesus.
 3. **Overture regarding Human Sexuality Report**
 - 3.1. Material: Att.12a - Overture from Four Churches; Att. 12b - Ottawa Calvin CRC Communication; Att. 12c - Committee of Pre-Advice
 - 3.2. Committee of Pre-Advice chair Pastor Dan Hoogland leads classis through their report and reads the recommendation:
 - 3.2.1. **Motion that CEC adopt the overture to receive the Synodical report from the Committee to Articulate a Foundation-Laying Biblical Theology of Human Sexuality for information, along with the recommended actions.**
 - 3.2.2. Chair closes the discussion with prayer at 9 pm

Saturday, March 5, 2022 meeting continues

4. ZOOM links open and at 8:15 everyone in breakout rooms for time of fellowship.
5. Chair Pastor Joe Groeneveld reads from first verses of Habakkuk in light of events in Ukraine. Prayer at the end 3:16... scary as he hears enemy coming...yet as 3:17f says God is our strength. Hard words to hear...we are going to die yet we belong to our Savior. We suffer with Ukrainians and Russians who disagree with their leaders. Joe leads us in prayer
6. CEC returns to the committee of pre-advice motion – Dan Hoogland, chair of committee
 - 6.1. Following questions for clarification the delegates vote by polling on their devices.
 - 6.2. **The above motion is adopted** to be forwarded to Synod 2022. Don Draayer requests to record his negative vote.
7. **Reports**
 - 7.1. Stated Clerk [Bernie Bakker] – Agenda Att. 1

7.1.1. Stated Clerk reported on work done since last CEC meeting e.g. planning a hybrid CE or in person meeting; process of setting up this meeting of Classis; classical appointments for Truro; arrangements for Synodical Deputies, etc.

7.1.2. **Motion: that CEC approve the work of Stated Clerk. Adopted**

7.2. Classis Interim Committee [Gregg Lawson, chair] – Agenda Att. 2

7.2.1. CIC reviewed survey of last CEC meeting in planning for March, 2022 meeting of Classis. As a result, and a desire to meet in person to discuss the overture on the HSR, CIC investigated setting up a hybrid meeting of Classis in consultation with host church Fellowship CRC, Barrhaven. Based on probable COVID guidelines survey were sent out to councils re compliance and willingness of volunteers. The end decision was to have meeting via ZOOM.

7.2.2. The Developing CEC Priorities Committee plans to meet as COVID eases.

7.2.3. The annual Financial Statement will go through an annual review process rather than a full annual audit. This was recommended by CEC accounting firm.

7.2.4. CIC also sent four representatives to the Canadian Catalytic Conversations hosted by Classis Niagara. The minutes of this conversation were sent to all churches in CEC.

7.2.5. **Motion: that CEC approve the work of the Classis Interim Committee. Adopted**

7.3. Credentials Committee [Jack Van de Hoef]

7.3.1. Safe Church Policy question: Renfrew and Truro policies are being updated.

7.3.2. Williamsburg asked about biblical defense for vaccine passports for worship service attendance. Vaccine requirements are changing so no further study on this matter.

7.3.3. Athens requests a future CEC discussion based on an article from Faith Today regarding church policies in a changing world. CIC to consider this for a future meeting of CEC.  4. Regional pastor Jack Van de Hoef supports Stephen's request.
