Friday, October 21, 2022 - 10 am

1. Constitution of Classis and Opening Devotions

- 1.1. Delegates gather in Barrhaven Fellowship's new facilities. Four delegates from the Maritimes join the meeting via ZOOM.
- 1.2. Host church Fellowship CRC, Ottawa Barrhaven Pastor Rick Nanninga, welcome all delegates and guests and led in opening devotions along with members of praise team. 2 Kings 6:15-17 was used to remind us that when surrounded by challenging life situations we often ask, "What shall we do?" we know that Christ holds us. Our prayer for each other is, "set your heart of things above." Delegates took time to write out those concerns and put them in a bowl in front of the cross.
- 1.3. All congregations are represented by their delegates. Pastor Rick notes that:
 - 1.3.1. Pembroke is not able to send delegates.
 - 1.3.2. Pastor Carel Gelynse, interim pastor in Charlottetown, is seated as a delegate.
 - 1.3.3. Pastor Rick declares Classis Eastern Canada constituted and introduces the executive.
- 2. Rev. Jack Van de Hoef serves as chair and Rev. Gregg Lawson is vice chair for the meeting.

- 2.1. Pastor Jack thanks Rick for his devotion and welcomes the following guests: Mwikali Wambua [Resonate Global Mission Kenya]; Marinus Koole [Christian Stewardship Services]; Echo McLeod [World Renew]; Rev. Al Postma [Transitional Executive Director Canada Ministries]; Michelle DePooter [Ministry to Seafarers]; Rev. Winston Visser [Outreach Mission Team Developer]; Candidate Ryan Farrell [Ottawa Campus Chaplain].

 - 10.2. All Nations CRC Halifax Diversity in sending delegates to Synod
 - 10.2.1. That Classis Eastern Canada ordinarily send delegates to Synod people from 4 different congregations or at most 2 from the same congregation. If the ballot is such that the numbers from one congregation exceed this, the Personnel Committee and the Executive of the Classis meeting (Chair, Vice Chair, Clerk) shall propose to the body a way forward in the voting that respects the need for diverse voices from our Classis.

- 11. Correspondence Committee Ottawa Calvin and Ottawa Calvary
 - 11.1. Code of Conduct Feedback from Church Council
 - 11.1.1. It is recommended that printed feedback along with questions from councils be forwarded to the Office of the General Secretary as requested in correspondence from the General Secretary. Councils are asked to forward this material before December, 2022.
 - 11.1.2. The Stated Clerk will gather this material along with comments from Saturday conversation and forward to General Secretary.
 - 11.2. Montreal Communication
 - 11.2.1. Montreal Council appreciates the efforts everyone puts in at the classis level and are blessed to hear about the work done with classis. Yet, there are several concerns: that at times it seems elder or deacon participation is not welcomed; overture committee

- recommendations not always precise is light of overture to CEC; communications within CEC do not always go to all congregations.
- 11.2.2. It is recommended that CIC process these concerns encouraging all of us to be sensitive to these matters.
- 11.2.3. Churches are encouraged to send notices of important events to all churches in Classis. The Stated Clerk can forward these notices if asked to do so.
- 11.3. The report of correspondence committee is received for information.

12. Oversight Committee Updates

- 12.1. Classis goes into executive session as reports regarding John Calvin CRC Truro, Rev. Nick Baas and Rev. Andrea Baas are read.
- 12.2. In open session Rev. Andrea Baas is declared eligible for call in the Christian Reformed Church. All Nations CRC Halifax is asked to make this announcement upon receiving Pastor Andrea Baas' credentials.

13. Synodical Delegates Report and Conversation

- 13.1. The delegates to synod are invited to share their experiences at Synod in light of the hard discussion regarding Synod's decisions related to the Human Sexuality Report.
- 13.2. One delegate shared a comment regarding the pain and hurt of the discussion and decisions as it was felt that members of LBTQ+ community were not heard. How can we ministry to a community that feels they do not matter? Another delegate mentioned the positive process of restructuring and the vast outreach ministries of the CRC; reaching students on campus, media ministry, international opportunity in Word and deed, etc. Delegates are encouraged to consider being on nomination for a pastor, elder, or deacon delegate next year.
- 13.3. Classis delegates spent time at their tables using listening conversation questions to share thoughts and concerns re synod's decisions regarding the Human Sexuality Report.

 - 14.2. Michelle De Pooter Ministry to Seafarers, Montreal: Michelle shares stories of three seafarers.
 - 14.3. Jacynthe Vallencourt Mission Montreal: Jacynthe shares about people being trained to be missional in their particular culture.
 - 14.4. Ryan Farrell Ottawa Campus Chaplain: Ryan share store of "hospitality" to the students; it's about being a presence even if some plans do not work out. The Holy Spirit is at work.
 - 14.5. Winston encourages all to listen and respond; we celebrate Mission with cake and fellowship. Share your story.
