### 3.1.1. Motion: that CEC approve the work of Stated Clerk.

- 3.2. Classis Interim Committee [Jack Van de Hoef] Agenda Att. 2
  - 3.2.1. CIC transferred the ministerial credentials of Steven Eckersley, Cornwall to Hagersville CRC, Classis Hamilton and Dan Zylstra, Athens to Meadowvale CRC, Classis Toronto.
  - 3.2.2. The Classis webpage has been updated. https://classiseasterncanada.ca/
  - 3.2.3. There has been some confusion about churches qualifying for classical appointments when they have hired an interim pastor. CIC recommends the following clarification: "If a vacant church hires an interim pastor the church may not be eligible for Classical Appointments unless a CRC pastor is requested to administer the sacraments. In this case Classical Appointments may be scheduled for example once every other month."
  - 3.2.4. Oversight Committee for John Calvin CRC, Truro reported that their work is finished; CIC notified the council that they are eligible to begin the calling process in search of their next pastor. We give thanks to the committee for their work and keep Truro in our prayers as they consider next steps.
  - 3.2.5. CIC decided to invite Syd Hielema to facilitate a discussion on "Synod's decisions re office-bearers to be in compliance with biblical guidelines affirmed by Synod 2022 regarding same-sex marriage, etc.". The conversation will be given adequate time so everyone feels heard.
  - 3.2.6. There have been some questions raised with regard to delegates signing agreement with the Covenant of Office Bearers. Following discussion, the motion was made that "Delegates to classis are sent from their church council and CEC accepts the credentials of delegates as being in compliance with Covenant of Office Bearers. Therefore, delegates are not asked to sign agreement with Covenant of Office Bearers when they come to the Classis meeting." Note: first time delegates acknowledge their agreement with the Covenant of Office Bearers when they register online for the meeting of Classis.

  - 3.4.1. Classis is continuing to provided support to Chris Smid, Chris Zak, Justin Halbersma, and Kyle Ward. For full report see Agenda Att. 4,
  - 3.4.2. Chris Tibben, who CEC gave financial support during seminary, decided to serve New Hope Baptist Church in Tillsonburg. As per the underlined statement from our previous report, CMLT is proposing partial forgiveness of the support Chris received from Classis due to his new ministry position. Because it is outside of our mandate to forgive support on the basis of non-CRC ministry, we're seeking Classis' approval for the following:

**CMLT moves that Classis forgive 2.5% of Chris Tibben's total support for every year that he serves in non-CRC ministry for up to 10 years and 25% of his total.** Grounds: - Our current policy is to forgive support for those in CRC ministry at a rate of 10% per year for up to 10 years and 100% of the total. This arrangement would follow the same pattern but at a reduced rate (and total) of forgiveness.

Offering forgiveness at a reduced rate both maintains the intent of our support (namely, to specifically promote leadership in the CRC) while also acknowledging the value Chris' education is now having in the broader body of Christ. Adopted

deacons, and guest are at round tables with their peers. CIC organized this conversation so we could have a safe place to have this conversation as we are not all on the same page regarding Synod's decision on the HSR report. Reflections centered around a long-term conversation rather than a quick fix to our differences. We need to remember God was never in a hurry. Syd shared various principal positions and postures concerning the human sexuality report as well as principal ways of interacting with Christians whose position and posture are different than mine; let us remember that iron sharpens iron. The Holy Spirit is praying for the church even when we grow tired and weary. We were thankful for this time of sharing and listening as the Lord is building His church. May the conversations continue in the spirit of Philippines 2:1-11.

- 7. <u>Al Postma, Transitional Executive Director Canada</u> shared some information about Our Journey 2025 which has not been extended to 2030. *"He explained 3 understandings of denomination: -- denomination as community of churches: there are four anchor points in Our Journey 2025,* 
  - 1. Cultivate practices of prayer and spiritual disciplines,
  - 2. Listen to the voices of every generation,
  - 3. Grow in diversity and unity by seeking justice, reconciliation and welcome,
  - 4. Share the gospel, living it missionally and planting new churches in our neighbourhood

-- <u>denomination as ministries</u>: there is a lot of strength and goodness in the many ministries -- <u>denomination as governance</u>: bi-nationality was a struggle in the past, but it is good after some fundamental shifts that have happened. The structure supports a good organizational working relationship." [from CEC summary written by Jack Van de Hoef].

Al also engaged in questions from the delegates regarding CRC in Canada, etc. We are thankful for this open discussion on some difficult themes.

- 9. <u>THRIVE Ministry</u> [Leslie Van Milligan]; <u>www.crcna.org/Thrive</u>

- 9.1. This past year COD/Synod integrated the ministries of Chaplaincy and Care Ministry, Disability Concerns, Faith Formation, Office of Diversity, Office of Social Justice, Pastor Church Resources, Race Relations, Safe Church, and Worship Ministries into one ministry called *Thrive. "In coming together as Thrive, we seek to provide churches with one-stop access to support resources that are fully integrated, and responsive to the changing needs of local congregations."* – from Thrive webpage.
- 10. Resonate Global Mission [Beth Fellinger, Eastern Canada Leader] Agenda Att. 17
  - 10.1. Beth tells us about the work of missions in multiply areas: e.g., Coffee Break, Church Planting, sending missionaries, encouraging congregations to become more diverse, etc. Check out Resonate Global Mission multiple ministries at <a href="https://www.resonateglobalmission.org/">https://www.resonateglobalmission.org/</a>

  - 11.1. "Over 150 people gathered May 25-28, 2023 in Ottawa, Ontario on the campus of Algonquin College for the Canadian National Gathering. Representatives from every classis across Canada participated. A key area of emphasis was on Hearts Exchanged and the work of reconciliation with Indigenous brothers and sisters."   - 11.2. Winston encouraged congregation to consider involvement in Hearts Exchanged or invite Adrian Jacobs as a guest speaker to learn more about justice and reconciliation.
- 12. Council of Delegates [Dan Meinema]
  - 12.1. The COD met last week so there is no written report. Dan gives a brief review of what is in the Banner. A summary of COD decisions is being sent out with the CEC Minutes.
- 13. World Renew [Echo McLeod] Agenda Att. 18
  - 13.1. Echo shares about the work of World Renew as staff and volunteers work in areas of disaster. We are grateful for the generous support of Classis as we help those who suffer beyond what we can imagine. We are encouraged to be part of a Disaster Response Team. Check out <u>https://worldrenew.ca/volunteer</u>
- 14. Credentials and Instructions [Halifax and Montreal] complete report on file
  - 14.1. 18 of 19 church councils sent credentials as Pembroke was not able to send delegates; five churches are vacant; some council only sent one delegate; and some delegates could only attend on Friday or Saturday. RFI
  - 14.2. Safe Church Policy: Immanuel CRC, Cornwall is actively implementing their policy; Renfrew has a policy but no training and screening staff and volunteers. Renfrew encouraged to put a plan in place for training and screening. RFI
  - 14.3. "Kanata CCC includes families with LGBTQ+ members and persons who are close friends with LGBTQ+ persons. We recognize we have not always ministered well with these members and, in the last few years, synodical decisions have made it more challenging. We resonate with Synod's apology to LGBTQ+ persons and its call out to 'all congregations

of the CRCNA to show love to all peoples, including our LGBTQ+ members and neighbors. ...' We suggest that Classis Eastern Canada consider hosting a special session on "how to show love for our LGBTQ+ members and neighbors" that includes (a) listening and learning from the real-life experiences of LGBTQ+ in CRC churches and (b) learning from churches with effective ministries that include more than one LGBTQ+ person." We suggest this session could be held in conjunction with a future classis meeting."

- 14.3.1. Note: Kanata CCC's Council wrote this before they learned of the session planned for this classis meeting
- 14.3.2. Our committee encourages CIC to have such a session, as a follow-up to this meeting's session, and due to the need to learn to grow into this call from Synod to listen to LGBTQ+ voices and to listen to congregations/ministries that have done this work effectively.
- 14.4. Williamsburg: "The CRCNA defines inactive members as members who for one year have not made faithful use of the means of grace, especially the hearing of the Word and the Lord's Supper, unless there are extenuating circumstances. If members do not return to the regular Sunday morning worship services, even after the pandemic is over, are they considered active or inactive?"
  - 14.4.1. Our committee encourages Williamsburg to ensure they've done appropriate follow-up with members who are returning to regularly worship services (Louis Tamminga's Elder Handbook has some guidance for this, particularly Ch. 37 & 50), and, if it's evident that these people are not planning to return, transfer to another church, or withdraw their current membership, it is fair to declare them inactive or even consider lapsing their membership (after two years from their departure).
- 15. Financial Administration Committee [Eva Reitsma, treasurer] Agenda Att. 7a-k
  - 15.1. Eva presented the Proposed 2024 Budget for Classis Eastern Canada. The 2024 budget is based on 1925 confessing members, down from 1964 for 2023 budget. **The 2024 budget is set at \$197,370 with a per member share at \$92.50.**
  - 15.2.Motion that CEC adopt the proposed 2024 budget as presented.Adopted
