- 3.8. Ministry to Seafarers, Montreal Att. 9
  - 3.8.1. Chaplain Michelle DePooter shares about the work to seafarers. At Christmas time over 1,400 parcels were delivered to the crews. The safety of crew members is a concern especially as some travel through the Suez Canal waters; their families abroad are concerned. Michelle is thankful the Centre is open in the evenings so Cruise Ship crew members have a place to retreat after work.
- 3.9. Ottawa Campus Chaplaincy Att. 10
  - 3.9.1. Chaplain Ryan Farrell spoke on the ministry emphasising refugee, safety, and peace for the students. He shared several stories of care ministry to students who come for a visit.
- 3.10. Diaconal Ministries Att. 11
  - 3.10.1. The report was received for information.
  - 3.10.2. Winston Visser is now Diaconal Coach for Quebec and Eastern Ontario. We thank Chris Smid for serving as coach over past several years.

Grounds: 1. The decision to sign this communication was one that took Calvary CRC a considerable amount of time. It involved significant communication with their congregation and considerable deliberation by their Council. To make this decision for classis, when it would not reflect the official position of a majority of the churches in classis, would be unwise.
